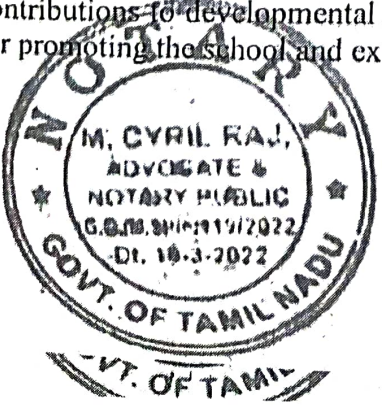

5. That school is not paying any charges towards using name, motto, logo or any other non-academic activities to any other institution, organization or body.
6. That the school will not open classes under CBSE pattern particularly class IX/X/XI/XII and will not use CBSE name in any manner without obtaining affiliation.
7. That the Principal and Correspondent/Manager of the School have individually gone through the provisions contained in the affiliation and examination byelaws, circulars issued by the Board from time to time. The School undertakes to abide by the provisions contained in the affiliation and examination byelaws, directions issued from time to time and the law of the land.
